



# Mac OS X Up-To-Date

Make sure your new Mac has the latest version of Mac OS X.

Mac OS X v10.6 Snow Leopard refines the elegant Mac OS X user experience with lots of little touches and performance improvements that will make using your Mac even more enjoyable. It also includes a few big foundation technologies designed to tap the power of today's computer hardware and provide a strong base for innovation.

Customers who purchase a qualifying product (defined in the Terms and Conditions) between June 8, 2009, and December 26, 2009, can upgrade to Mac OS X v10.6 Snow Leopard for US\$9.95 (subject to applicable Terms and Conditions).\*

## Qualifying Products

A Mac computer (referred to as a "qualifying product") qualifies for this program if it was sold by an Apple Authorized Reseller or Apple Inc. between June 8, 2009, and December 26, 2009, and does not include Mac OS X v10.6 Snow Leopard. (see "Terms and Conditions" for qualifying computers). Your date of purchase and the computer marketing part number are used to determine whether your order qualifies for this program.
